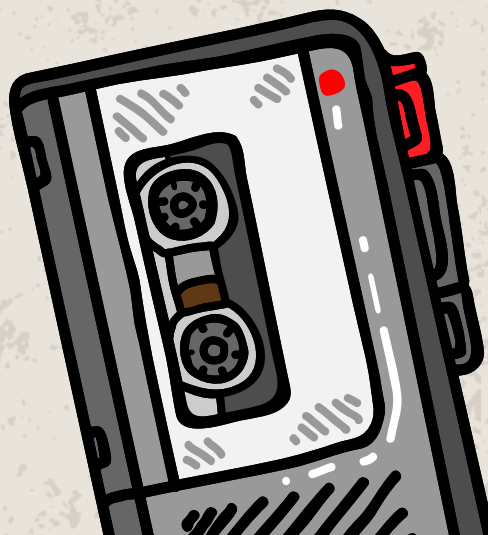
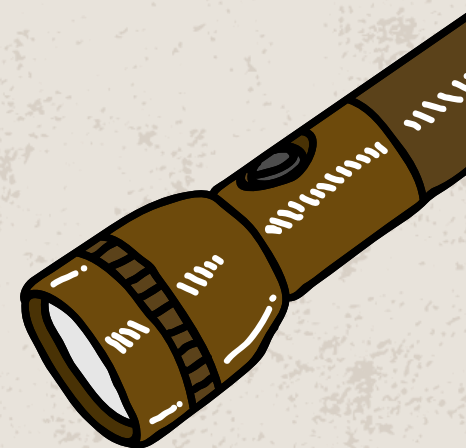

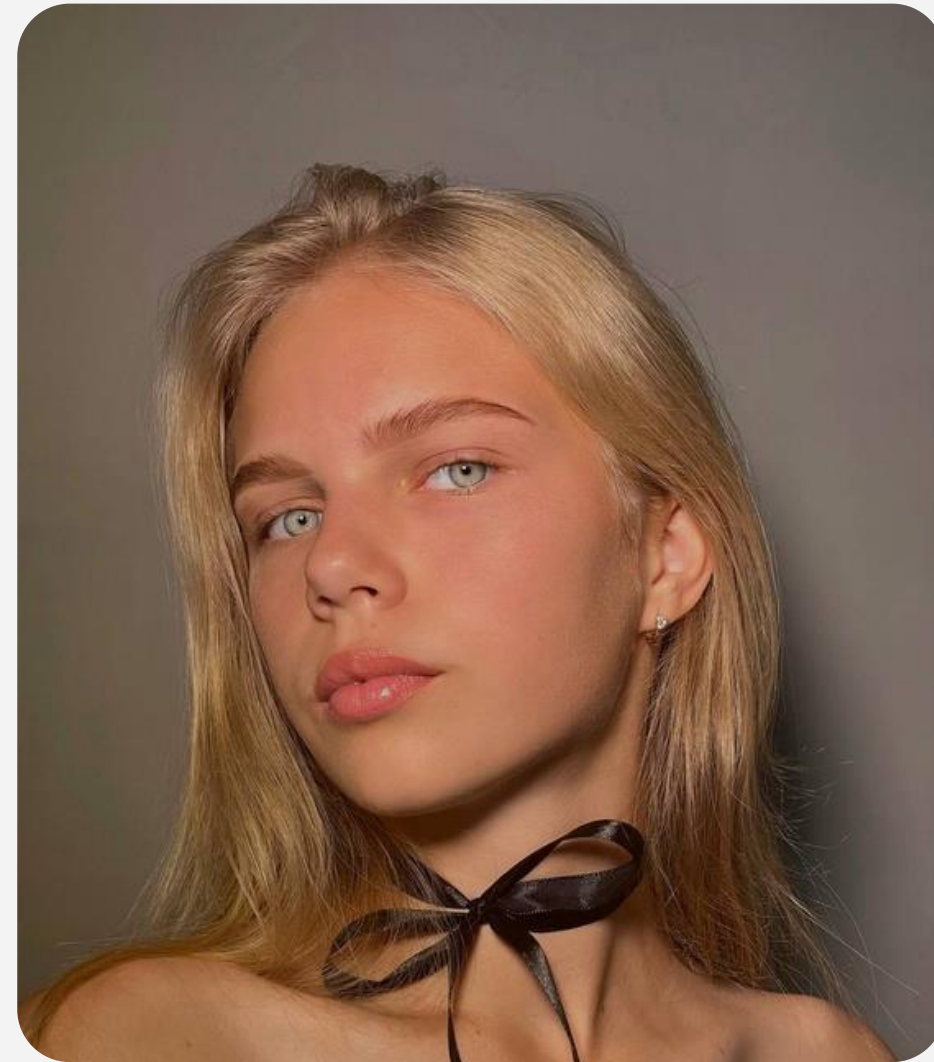

CORRUPTION

This is the use by a person of the official powers granted to him or her or related opportunities for the purpose of obtaining illegal benefits (money or property) or accepting such benefits, or also accepting a promise/offer of such benefits for themselves or others.



DISHONESTY

This is a broader concept, which means the absence of ethical principles or violation of moral norms, but it is not always associated with illegal activity.

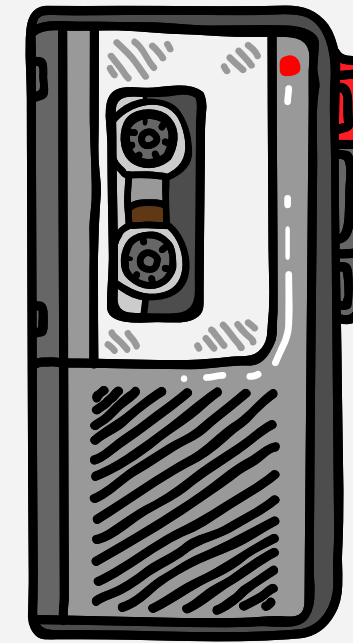
BODIES ENGAGED IN EXPOSING CORRUPTION

- National Anti-Corruption Bureau of Ukraine (NABU)
- Specialized Anti-Corruption Prosecutor's Office (SAPO)
- National Agency for Corruption Prevention (NACP)



WHISTLEBLOWER

This is an individual who is confident that the information is reliable, and who reported possible facts of corruption by another person, if such information became known to him/her in connection with his/her labor, professional, economic, public, scientific or any other activity.



A PERSON MAY BE CONSIDERED A WHISTLEBLOWER



UNDER THE FOLLOWING CONDITIONS:

1

an individual (citizen of Ukraine, foreigner, stateless person) who is convinced that his/her information is reliable must report corruption;

2

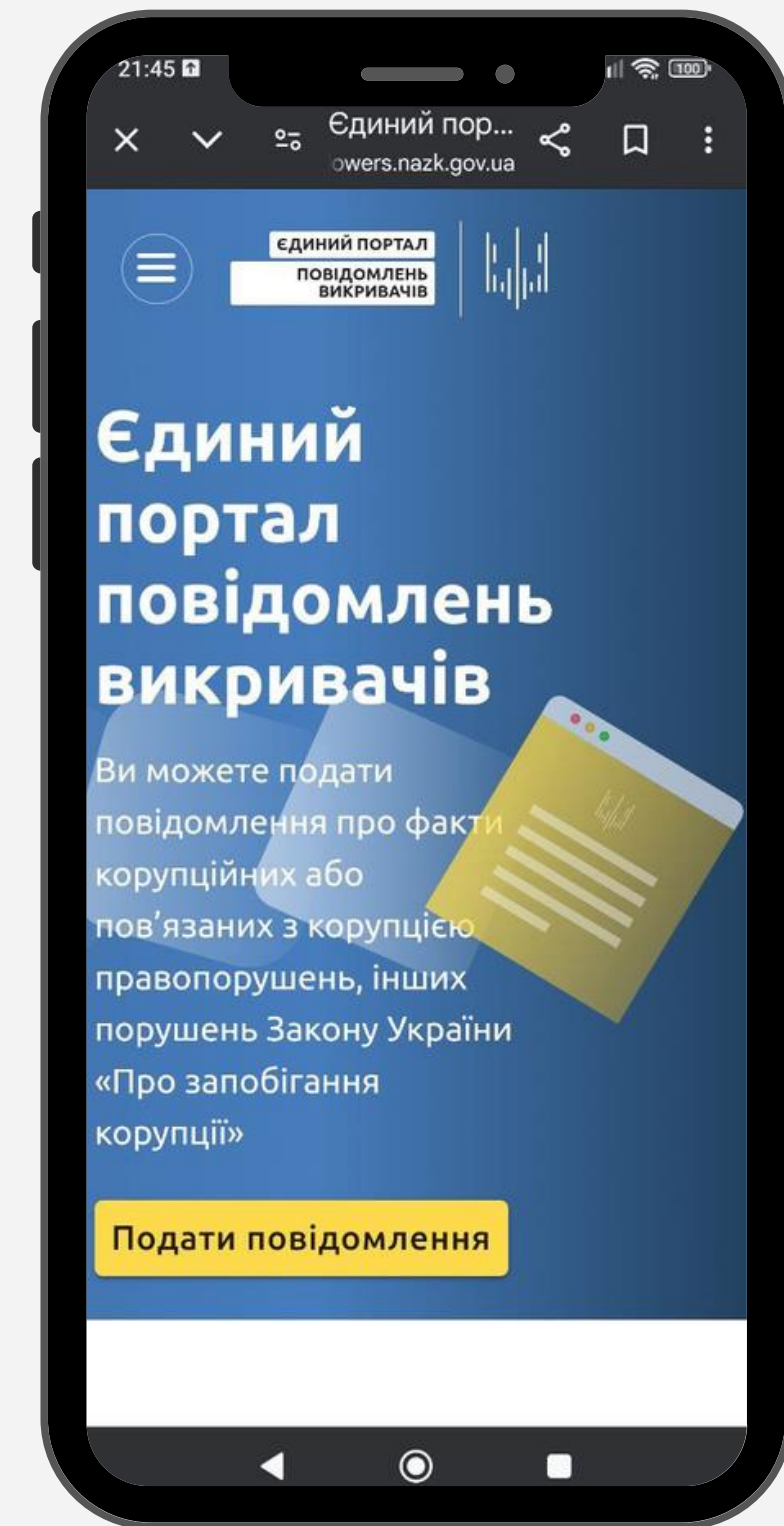
the information provided in the message must contain facts that prove the possible commission of a corruption or corruption-related offense by another person, which can be verified;

3

this information became known to them in connection with their labor, professional, and economic activities, social, scientific activities, their service or training.

"Unified portal of whistleblowers' messages"

The "Unified portal of whistleblowers' messages" is an online platform, a site where a person can anonymously report corruption. The Unified portal of whistleblowers' messages guarantees compliance with the terms of confidentiality and anonymity to whistleblowers, as well as provides whistleblowers with access to information about the status and results of consideration of their messages and is an official internal source of information about persons who have the status of whistleblowers.
